

# TROPIXPLOSION!

## Contract Rider

THIS RIDER IS ATTACHED TO AND MADE A PART OF THE BAZILLION SONGS CONTRACT DATED \_\_\_\_\_ / \_\_\_\_ / \_\_\_\_\_ BETWEEN TROPIXPLOSION! (hereinafter referred to as ARTIST) and \_\_\_\_\_ (hereinafter referred to as PURCHASER).

The rider is an integral part of the contract, and adherence to it will enable the artist to give you the best possible performance. Any changes or questions pertaining to the rider or contract must be directed to Bazillion Songs, LLC. All terms and provisions herein after and herein before set forth part of one and the same contract.

PURCHASER AGREES TO PROVIDE THE FOLLOWING AT SOLE COST

1. TECHNICAL REQUIREMENTS: \*\*

- A. Stage Size: 16' x16' or 20' x 12'
- B. Parking must be provided at no cost to the band close by the performance area/entrance.
- C. Specific instructions regarding the loading dock, security clearance and confirmation of parking must be provided below.
- D. The decision to move to alternate indoor location must be made PRIOR to arriving.
- E. If inclement weather is imminent or predicted and proper shelter or an alternate indoor location is not provided, the show will be cancelled and payment will be due in full.
- F. Stage Plot and Input List provided separately and will vary depending on the performance.
- G. Power 2 x 20 amp circuit
- H. \*\*A proper sound check is required. Doors may not be opened until sound check is completed as approved by member of band.

2. HOSPITALITY

- A. Meal for Five (5) to Seven (10) people depending on size of band for the event. One (1) must be vegan.
- B. Assorted sodas and juices.
- C. Five (5) to Seven (10) large bottles of water.
- D. Two (2) loaders required before and after the show

3. PERFORMANCE NIGHT

- A. PURCHASER to supply artist with temperature controlled dressing room, which includes or has access to washroom. Room to be secured during performance. Whenever possible, room should have table and chairs, mirror, ice water.
- B. No part, portion or segment of any performance may be broadcast or reproduced either by audio or video means without express written permission of the ARTIST.

Tropixplosion! will be allowed to cancel their performance with no prior notice in the event that they are hired to appear on a Television show, in a feature film, or a Television commercial at a time that conflicts with his scheduled performance. In the event that Tropixplosion! cancels their performance, Tropixplosion! or the agency representing Tropixplosion! for that performance will supply a suitable replacement or reschedule Tropixplosion on an agreed upon date.
